## **ISLAMABAD POLICE have registered a case against 23 people Protesting**

**against arrest of Manzoor Pashteen**

**USPA NEWS** - Islamabad police have registered a case against 23 people protesting against the arrest of Manzoor Pashtin, the head of the Pashtun security movement (PTM).

The FIR designates 23 people and accuses them of wrongdoing. However, no member of the National Assembly, including Mohsen Dawar, was nominated in the case, but three leaders, including Mohsen Dawar, were released overnight after being taken into custody.

Islamabad police have filed a case against the Pakistani authorities under the Act 124A / 341/50511/353/186/147/149 / 505A / 188 /. The FIR text states that at around 4:15 pm, information was received that the Press Club Islamabad Pukhtoon Protection Movement and Awami Workers Party workers and officials were in front of the Press Club and that more protesters had gathered. have been.

Approved Pashtun leaders are protesting about the arrest of PTM, so fear of disturbance is reported on the area. The magistrate came to the press club around 4:30 pm, and Mohammad Athar Khan Inspector, Ishtiaq Hussain ISI, Mohammad Nawaz came to the press club. Thahal SI and Rafiullah SI, Kamal Khan ASI, Bilal 36C Talib Hussain 39301lc, Faizan Press Club were present and 50/60 protesters were present.

Demonstrators were told that there is a Section 144 Code of Criminal Enforcement within the premises of Islamabad. Instead of dispersing on the occasion, more than five or three people are banned so that instead of being dispersed, the protesters started chanting slogans and speeches against the state of Pakistan and Pakistan, and the protestors hated and protested. Inclined to peace and the protesters chanted slogans in favor of Pashtuns, the slogan behind this terrorism is uniform.

The people were encouraged to block the road by chanting slogans against the state and forces of Pakistan, when the protesters left the press club ground to block the high street from which more police forces were dispersing the protesters. Some of the protesters were dispersed and some protesters were present on the occasion. However, later discoveries are as follows.
